POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 9 JUNE 2023

The board (the “**Board**”) of directors (the “**Director(s)**”) is pleased to announce that all the proposed resolutions were duly passed by the Shareholders by way of poll at the AGM.

Reference is made to the circular (the “**Circular**”) of Realord Group Holdings Limited (the “**Company**”) and the notice (the “**Notice**”) of the annual general meeting dated 28 April 2023. Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

POLL RESULTS OF THE AGM

At the AGM held on 9 June 2023, all proposed resolutions as set out in the Notice were taken by poll. The Company’s branch share registrar and transfer office in Hong Kong, Tricor Tengis Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.

As at the date of the AGM, the total number of issued shares of the Company was 1,440,709,880 Shares, which was the total number of Shares entitling the Shareholders to attend and vote on the resolutions at the AGM. No Shareholder was required to abstain from voting in favour of the resolutions at the AGM, and there was no Share entitling the holders thereof to attend and vote only against the resolutions at the AGM. No person had indicated in the Circular of his intention to vote against or to abstain from voting on any of the resolutions at the AGM.

The AGM was chaired by Dr. Lin Xiaohui, an executive Director and the chairman of the Board. The executive Directors, Madam Su Jiaohua and Mr. Lin Xiaodong, and the independent non-executive Director, Mr. Ho Chun Chung Patrick attended the AGM in person; and the independent non-executive Directors, Mr. Yu Leung Fai and Mr. Fang Jixin attended the AGM by electronic means.
